To ensure the contribution is reported for the proper tax year, please notify the credit union staff member that your contribution is for 2010. As with all tax-related concerns, you may wish to consult with a qualified tax expert to answer any IRA related eligibility and contribution questions.





QCR Letters

During 2010 letters were mailed to a randomly selected group of members. This letter was requesting participation in a survey for the credit union that would continue for the entire year. Members interested in participating were referred to as Quality Control Representatives (QCR's) and received a deposit of \$10 for each month that they participated.

Blue Chip FCU appreciated the participation from all of those QCR's and thanks them for their assistance in helping us to better serve you. 2010 was the first time QCR's provided feedback to the credit union and suggestions were made to improve the process. During the beginning of 2011 letters will be sent requesting again for QCR assistance in 2011. For those that participated in 2010, you will be receiving that request letter yet again. We anticipate a faster turnaround time for feedback, therefore leading to a faster turnaround for those \$10 deposits!

If you receive a letter asking for participation in the 2011 QCR survey, we encourage you to help us improve our service to you by completing each monthly survey and returning them by the date listed. Participation is completely up to you and remains anonymous.

Credit Cards Among Young Adults

Credit Cards are offered in retail stores, college campuses, and financial institutions, just to name a few. They can be found almost too easily and often seen as easy cash to young individuals. Credit cards can be an effective tool in establishing credit, budgeting, and debt management but can also create unwanted accumulated debt if they are not managed effectively.

It is important to teach young adults how to gain good credit but without the proper guidance, we can negatively affect our future spending and credit score. A credit card is not fast or instant cash. It is a small loan that requires monthly payments in paying back what was borrowed. The card will have a set limit based on guidelines from our loan department. For someone who is just starting out, I recommend a VISA debit card or a prepaid visa gift card, both available at the credit union. This may be a smart starting point for money management practice. A VISA debit card is connected to your checking account and requires you to keep track of all expenditures. A VISA gift card, which is not related to your checking account, can be bought from the credit union and then used on purchases. However, this also requires you to keep a record of what is spent until the card's balance reaches zero. If these cards can be effectively managed, you can try a credit card for emergency purposes. Like any other loan, you would need to have income to make payments for the money borrowed and the accumulated interest. Blue Chip FCU offers VISA credit cards, and these statements are sent to our members monthly, separate from the credit union accounts statement. The statement lists all information needed like expenditures, current balance, and the payment that is due. Payments can be made at the credit union, online, or over the phone. By making payments when they are due, you can establish good credit that ultimately affects future spending. With a little help from your credit union, money management can be made easy. If you have any questions about our VISA products or how they can help young adults please contact the credit union. We would be happy to assist you.
